Morgan Stanley also confirmed that an ACH will be set up for the transfers.

Alyce Spruell reminded Mr. Robinson that she previously responded to his request and she notified him that she will provide a copy of the letter to him and the board again. She also stated that she would provide the board with a copy of the Pension Act prior to 1999.
- Mike O'Bryant wanted to confirm that the City keeps the pension records at City Hall. Alyce Spruell confirmed that Rosen Harwood has scanned copies of the pension files but the original files are kept with the City.
